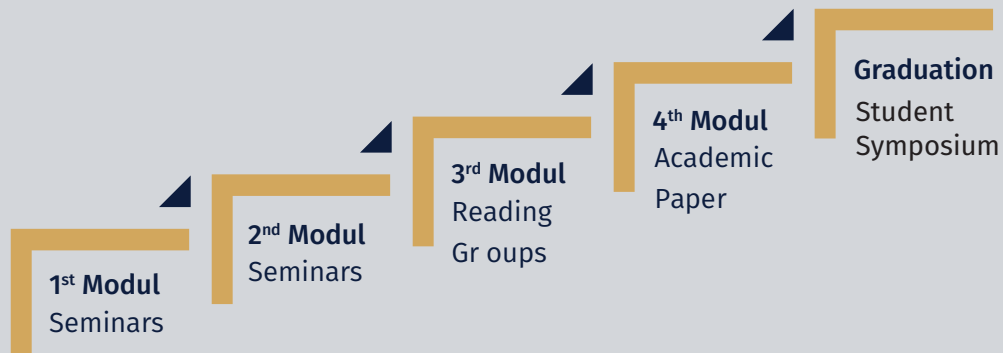

RESEARCH PROJECTS

BALKAN PERIODICALS: THE TRAJECTORY OF ISLAMIC THOUGHT, 1918-2018

Spanning from 1918 to 2018, the research delves into the periodicals published across the Balkan geography, examining the evolution of Islamic thought amidst the backdrop of historical transformations and societal shifts. By analyzing magazines and newspapers from Albania, Bosnia-Herzegovina, Bulgaria, Kosovo, North Macedonia, Greece, Montenegro, Croatia, Serbia, and Romania, the project aims to uncover the diverse range of ideas surrounding fiqh/law, kalam, state, society, politics, nation, culture, and women.

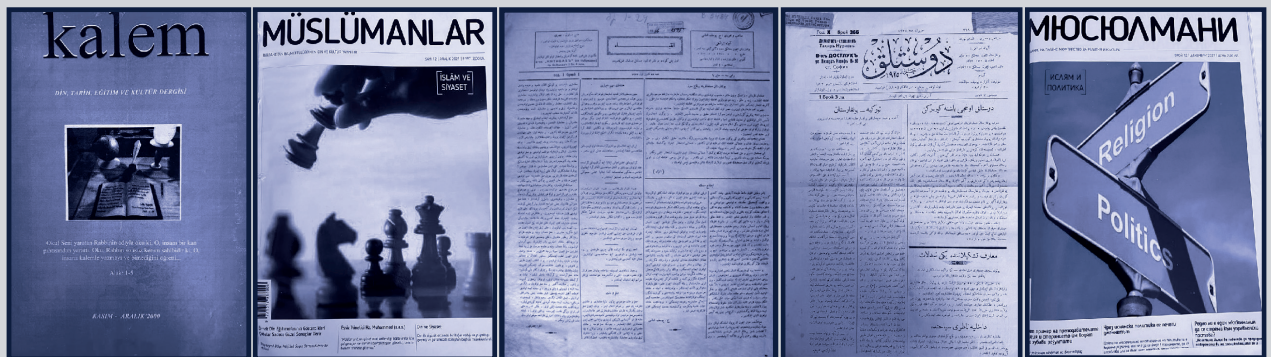




Through this exploration, the project seeks to unveil the transformations, ruptures, and continuity of Bosnian, Albanian, and Turkish Muslim identities at both national and regional levels. By providing a comprehensive overview of the trajectory of Islamic thought in the Balkans, this project promises to contribute significantly to scholarly understanding and discourse in the field.

The inventory process has been successfully completed through the meticulous work of seven researchers in their respective regions. Within this scope, 340 periodicals collected from different regions have been included in the inventory, resulting in a comprehensive archive comprising 15,000 issues and 2,500 pages.

The digitization process, however, is still ongoing. Technical infrastructure efforts are underway to transfer the collected periodicals and inventory data to digital platforms. Once this process is complete, the inventory is expected to become easily accessible to researchers and interested parties.



RESEARCH PROJECTS

BALKAN ECONOMIES: STRUCTURE, TRANSITION, AND TRANSFORMATION (1991-2023)

The Balkans, a region of profound historical and geopolitical significance, has undergone dramatic economic transformations over the past three decades. Following the dissolution of Yugoslavia in 1991, newly independent states, including North Macedonia, faced significant challenges in restructuring their economies, transitioning from socialist systems to market-oriented models, and integrating into the global economic order. The “Balkan Economies: Structure, Transition, and Transformation (1991-2023)” research project aims to examine the economic trajectories of various Balkan countries, as North Macedonia, Kosovo, Albania etc. while providing comparative insights into the broader region.

BALKAN POLITICS: PARTIES, IDEOLOGIES, AND SOCIETY (1991-2024)

The period between 1991 and 2024 marks a transformative era for Balkan politics, shaped by the dissolution of Yugoslavia, the emergence of new nation-states, the region's ongoing integration into the global political landscape as EU and NATO. This period has been characterized by significant political, social, and ideological shifts, as well as challenges in achieving democratic consolidation, regional stability, and socio-economic progress.

This research Project aims to provide a comprehensive analysis of the political evolution in the Balkans over the past three decades. It explores the dynamics of political parties, the ideological underpinnings of governance, and the interplay between politics and society in shaping the region's contemporary identity.

OTTOMANS AND BALKANS: SCIENCES AND CENTERS (1500-1800)

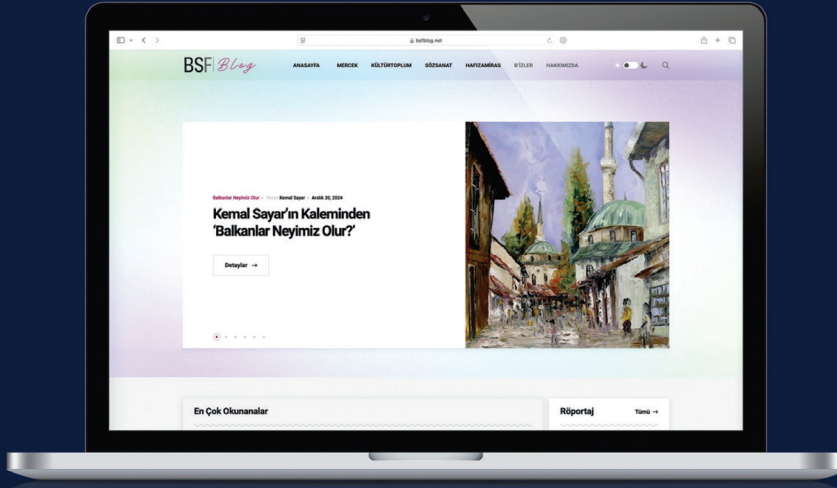
This research project aims to establish an international platform to evaluate the intellectual works of the Balkans—also referred to as Ottoman Europe—through an interdisciplinary lens. The primary goal is to uncover the sciences and intellectual hubs in the Balkans between 1500 and 1800. This project also seeks to integrate this heritage into modern contexts.

By analyzing historical intellectual hubs, connecting them with contemporary cultural dynamics, and developing a forward-looking roadmap, this initiative promises to contribute significantly to both academic scholarship and cultural integration efforts.

BALKAN SOCIAL SURVEY

The primary aim of this project is to produce long-term scientific data on the social structures of the Balkans. By generating this data, the project seeks to provide policymakers and stakeholders with a foundation for conducting comparative analyses and interpretations of the social structures of Balkan countries, supported by time-series data. These comparative insights will illuminate the transformations, ruptures, and future perspectives of the social structures within the Balkans and their respective nations.

In the initial phase, the project will focus on a short-term objective by analyzing the social structure of North Macedonia, Kosovo and Albania. Surveys will be conducted to gather data on these variables (demography, socio-economic structure, working life, housing, settlement, transportation, migration) which will then be analyzed to identify constants, trends, and expectations. This analysis will serve as the groundwork for understanding the broader patterns and tendencies within North Macedonia, Kosovo, and Albanian's social framework.



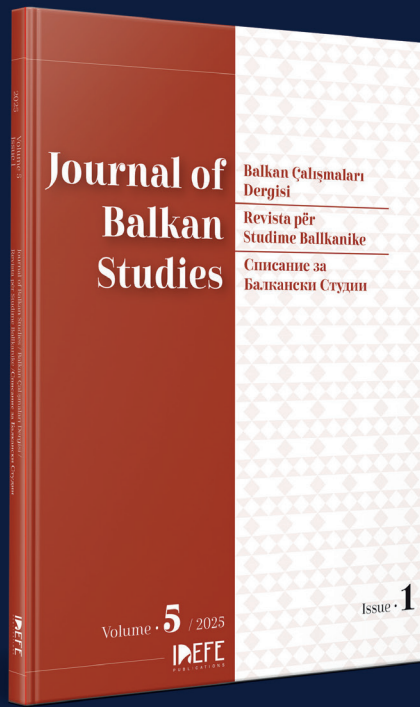

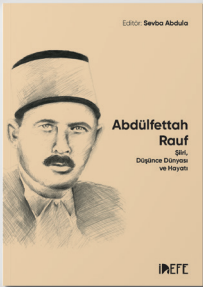
The territories of Rumelia from the early Ottoman period referred to as the Balkans in the late period and retrospectively termed Ottoman Europe by contemporary scholars maintained an exceptional status for seven centuries. While this district was initially shaped by the orientation of Ottoman conquest policy toward the West, historical research must also account for the fact that a profound intellectual and spiritual bond developed between scholars and students in this region and their counterparts in the Ottoman heartland and other Muslim lands a bond that strengthened over time. This volume undertakes to examine the scholars who emerged and the works produced across various disciplines in Ottoman Europe predominantly in the mathematical, natural, and philosophical sciences while further elucidating the inter-regional networks sustained through both these individuals and their scholarly output.

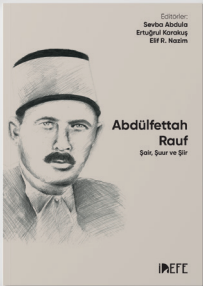

ABDÜLFETTAH RAUF: ŞİİRİ, DÜŞÜNCE DÜNYASI VE HAYATI

This work is devoted to Abdülfettah Rauf, a poet and scholar of the Balkans. He emerged as one of the prominent figures among Muslim communities who, during the first two phases of the twentieth century, experienced the loss of their economic, political, and cultural authority in the region. At the same time, he embodied the institutional legacy and intellectual ethos established by Islamic civilization in these lands.

His poetry, composed particularly between 1927 and 1963, assumes the character of a manifesto that affirms and preserves the cultural presence of Muslim communities who were forced to retreat, marginalized, and subjected to erasure. In this respect, his work stands as a deliberate act of historical inscription, bearing witness to a contested and transforming cultural landscape.



ABDÜLFETTAH RAUF: ŞAİR, ŞUUR VE ŞİİR

This volume constitutes one of the principal outcomes of the II International Symposium on Abdülfettah Rauf: Poet and Scholar of the Balkans held in Skopje on 25–26 April 2025, with the participation of distinguished academics and literary figures from various cities in Türkiye. It represents the product of a comprehensive scholarly effort that examines Abdülfettah Rauf from multiple perspectives.

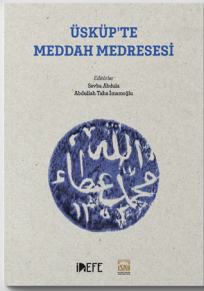

Nearly a century has passed since the Meddah Madrasa one of the earliest Ottoman madrasas in the Balkans was revitalized and reconstituted in 1923 by Ataullah Kurtish, a graduate of the Fatih Madrasa, thereby assuming a renewed institutional form.

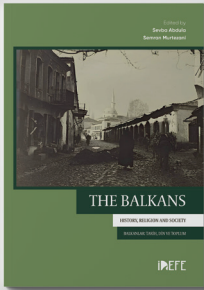

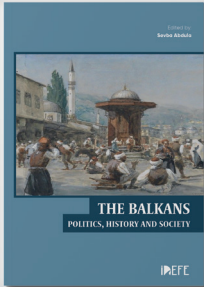

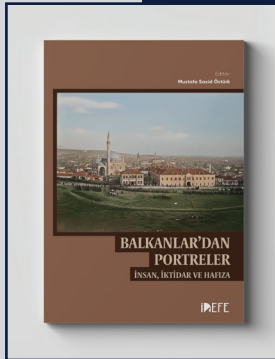


THE BALKANS: POLITICS, HISTORY AND SOCIETY

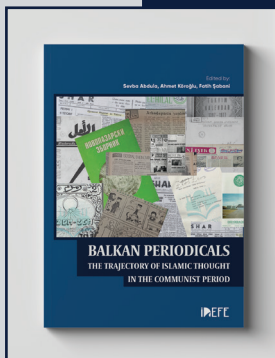

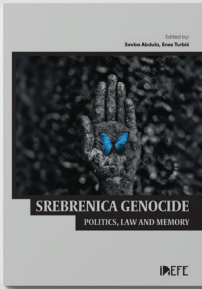

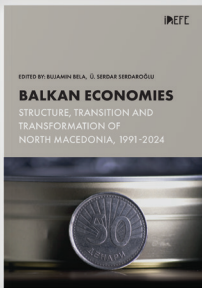
SREBRENICA GENOCIDE *POLITICS, LAW AND MEMORY*

Looking back at 1995 after thirty years, the genocide has become entrenched in collective memory, and Serbia has been condemned by international courts. However, numerous processes—such as the politicization of the issue, its background, legal debates, the reconstruction of memory, and genocide denial continue to persist. This work is the output of re-evaluating Srebrenica within an international framework thirty years later. Law, memory, media, and history constitute the primary themes of this volume.



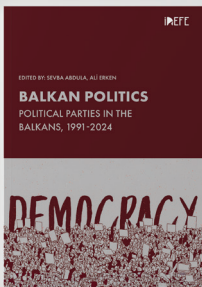

Abdülfettah Rauf's intellectual and literary struggle, conducted between 1911 and 1963 together with his companions in the Rumelian territories centered in Skopje, holds significant value for the representation of twentieth-century Balkan and broader Islamic geographies. Renowned in the region not only for his scholarly depth but also for his poetry, Abdülfettah Rauf has remained in scholarly and cultural discourse through his poetic corpus, which, for various reasons, had remained unpublished for over half a century. These poems, uncovered and compiled through the extensive research of the Balkan Studies Foundation, have been meticulously transcribed from the original Ottoman Turkish and published under the auspices of the Foundation.

In the last two centuries the modern state and its political power have faced various internal and external constraints, the state has managed to maintain its dominance by developing mechanisms that actively intervene in every aspect of life. While regions geographically closer to Western Europe completed these transitions earlier, the movement toward the south and east produced delayed and hybrid structures of modernization. This study examines one of the most striking examples of the modern state's intervention into history, space, and identity during the 2010s in North Macedonia, one of the most heterogeneous countries in the Balkan region.
